EXECUTIVE DIRECTOR'S REPORT

Executive Director Jeffers asked the Commission to consider the following resolutions.

RESOLUTION NO. 2017-1

RESOLUTION APPROVING CHANGE ORDER NO. 2 FOR YEAR TWO OF THE STRUCTURAL IMPROVEMENTS CONTRACT BCBC-201407.

WHEREAS, pursuant to Resolution No. 2015-60, the Burlington County Bridge Commission ("Commission") awarded Year Two of a contract to A.P. Construction, Inc. ("AP") for the project titled "Structural Improvements (BCBC-201407)"; and

WHEREAS, the Project Engineer recommended by memorandum dated December 19, 2016 that Change Order No. 2 be approved, and providing for an increase in additional repairs needed on the Burlington-Bristol and Tacony-Palmyra Toll Booths in preparation of the painting project; and

WHEREAS, this Change Order No. 2 requires an increase of \$500,000.00 in the contract price, bringing the new contract total to \$3,413,997.60.

NOW, THEREFORE, BE IT RESOLVED by the Burlington County Bridge Commission that, based upon the recommendation of its engineer, and after a thorough review of this matter, the Commission hereby approves Change Order No. 2 for AP for the project titled "Structural Improvements (BCBC-201407)".

Commissioner Singleton moved to approve. Vice-Chairman Fattorini seconded the motion. The motion passed unanimously.

RESOLUTION NO. 2017-2

RESOLUTION APPROVING CHANGE ORDER NO. 8 FOR THE BURLINGTON-BRISTOL BRIDGE BRIDGE MOUNTED STRUCTURES REHABILITATION PROJECT.

WHEREAS, pursuant to Resolution No. 2013-2, the Burlington County Bridge Commission ("Commission") awarded a contract to A.P. Construction, Inc. ("AP") for the project titled "Burlington-Bristol Bridge Bridge Mounted Structures Rehabilitation Project (BCBC-201220)"; and

WHEREAS, the Project Engineer recommended by memorandum dated January 5, 2017 that Change Order No. 8 be approved, providing for an extension of time of 306 calendar days bringing the new contract completion date to May 31, 2017 due to the authorized extra work for the new prefabricated operator's building with associated accessories approved in Change Order No. 7 and the anticipated maintenance access ladder and transverse balance counterweights extra work which shall be included in a future change order.

NOW, THEREFORE, BE IT RESOLVED by the Burlington County Bridge Commission that, based upon the recommendation of its engineer, and after a thorough review of this matter, the Commission hereby approves Change Order No. 8 for AP for the project titled "Burlington-Bristol Bridge Bridge Mounted Structures Rehabilitation (BCBC-201220)".

Vice-Chairman Fattorini moved to approve. Commissioner Singleton seconded the motion. The motion passed unanimously.

RESOLUTION NO. 2017-3

RESOLUTION AMENDING THE CONTRACT WITH WINDSTREAM CORPORATION.

WHEREAS, the Burlington County Bridge Commission ("Commission") has determined that it requires the services of a firm to provide various voice communication services for the Commission; and

WHEREAS, pursuant to Resolution No. 2016-156, the Commission entered into a contract with Windstream Corporation ("Windstream") to provide these voice communication services; and

WHEREAS, because third party service rates for voice communication services under this contract have increased, it is necessary to increase the appropriation for such services by an additional Twenty-Five Thousand Dollars (\$25,000.00).

NOW, THEREFORE, BE IT RESOLVED by the Burlington County Bridge Commission as follows:

- 1. The terms, conditions and duties outlined in Resolution No. 2016-156 appointing Windstream are incorporated herein by reference, and for the reasons hereinabove expressed, an additional sum of Twenty-Five Thousand Dollars (\$25,000.00) be and hereby is appropriated to pay the fees, expenses and costs pursuant to the existing contract between the Commission and Windstream.
- 2. Sufficient funds are available for payment for those services as evidenced by the Certificate of Availability of Funds, attached hereto.

Commissioner Singleton moved to approve. Vice-Chairman Fattorini seconded the motion. The motion passed unanimously.

RESOLUTION NO. 2017-4

RESOLUTION AMENDING THE CONTRACT WITH T & M ASSOCIATES FOR ASSOCIATE RESIDENT ENGINEERING SERVICES.

WHEREAS, the Burlington County Bridge Commission ("Commission") has determined that it requires the services of an engineering firm with expertise in matters involving operation and maintenance of the bridges under the jurisdiction of the Commission, and is capable of providing services as associate resident engineer and is also capable of providing services relating to structural and other repairs involving the Commission's bridges, construction inspection and monitoring relating to the Burlington-Bristol Bridge operating ropes replacement project, and engineering services relating to the Commission's yearly and in-depth inspection programs, among other projects as may be requested by the Commission; and

WHEREAS, pursuant to Resolution No. 2015-103, the Commission entered into a contract with T & M Associates ("T & M") to provide those professional engineering services; and

WHEREAS, additional engineering services under this contract are required for the construction inspection services for the Riverside-Delanco Bridge Fender System Repair Project; and it is necessary to increase the appropriation for such services by an additional Eight Thousand, Three Hundred Eighty-Seven Dollars and Forty-Eight Cents (\$8,387.48).

NOW, THEREFORE, BE IT RESOLVED by the Burlington County Bridge Commission as follows:

- 1. The terms, conditions and duties outlined in Resolution No. 2015-103 appointing T & M are incorporated herein by reference, and for the reasons hereinabove expressed, an additional sum of Eight Thousand, Three Hundred Eighty-Seven Dollars and Forty-Eight Cents (\$8,387.48) be and hereby is appropriated to pay the fees, expenses and costs pursuant to the existing contract between the Commission and T & M.
- 2. Sufficient funds are available for payment for those services as evidenced by the Certificate of Availability of Funds, attached hereto.

Vice-Chairman Fattorini moved to approve. Commissioner Singleton seconded the motion. The motion passed unanimously.

RESOLUTION NO. 2017-5

RESOLUTION AMENDING THE CONTRACT WITH CONTROL POINT ASSOCIATES, INC.

WHEREAS, the Burlington County Bridge Commission ("Commission") has determined that it requires the services of an engineering/architectural firm capable of performing on-call comprehensive surveying and other engineering related services; and

WHEREAS, pursuant to Resolution No. 2016-35, the Commission entered into a contract with Control Point Associates, Inc. ("CPA") to provide those professional engineering services; and

WHEREAS, modifications to the AutoCAD/Revit program are recommended for the 3D Model of the Burlington-Bristol Bridge Lift Span; and it is necessary to increase the appropriation for such modifications by an additional Thirty Thousand Dollars (\$30,000.00).

NOW, THEREFORE, BE IT RESOLVED by the Burlington County Bridge Commission as follows:

- 1. The terms, conditions and duties outlined in Resolution No. 2016-35 appointing CPA are incorporated herein by reference, and for the reasons hereinabove expressed, an additional sum of Thirty Thousand Dollars (\$30,000.00) be and hereby is appropriated to pay the fees, expenses and costs pursuant to the existing contract between the Commission and CPA.
- 2. Sufficient funds are available for payment for those services as evidenced by the Certificate of Availability of Funds, attached hereto.

RESOLUTION NO. 2017-6

RESOLUTION AUTHORIZING ENTRY INTO SECOND ADDENDUM TO THE SERVICES CONTRACT BETWEEN THE NEW JERSEY EZ PASS GROUP AND XEROX STATE AND LOCAL SOLUTIONS, INC. TO PROVIDE SERVICES IN SUPPORT OF THE NEW JERSEY EZ PASS CUSTOMER SERVICE CENTER.

WHEREAS, the Burlington County Bridge Commission ("Commission"), together with the South Jersey Transportation Authority, the Delaware River Port Authority, the Delaware Valley Joint Toll Bridge Commission, and the New Jersey Turnpike Authority, is a member of the New Jersey EZ Pass Group, pursuant to a Memorandum of Agreement executed by each of those agencies which memorializes, among other things, each agency's rights and obligations concerning the group collection of electronic tolls, as well as the oversight and the operation of the New Jersey EZ Pass Customer Service Center; and

WHEREAS, in 2015, prior to the formal establishment of the New Jersey EZ Pass Group, the Bridge Commission and the other toll collection agencies approved, by Resolution, participation with the New Jersey Turnpike Authority in a Services Contract between the Turnpike Authority and Xerox State and Local Solutions, Inc., which Services Contract had been duly procured by the New Jersey Turnpike Authority and was awarded on or about September 29, 2015; and

WHEREAS, following the award of the Services Contract, the agencies and the vendor discussed revisions to that Services Contract which would clarify the rights and obligations of the vendor and the agencies regarding invoicing and the payment of fees by the agencies to the vendor; and

WHEREAS, following a period of negotiation, the members of the Group and the vendor have reached an agreement with respect to amendments (identified as the "First and Second Addendums") to the Services Contract, for the purposes set forth above; and

WHEREAS, the Bridge Commission's staff and professionals have reviewed the proposed Second Addendum to the Services Contract and have recommended that the Commissioners authorize the Bridge Commission's entry into that Second Addendum; and

WHEREAS, the recommendations of the Bridge Commission's staff and professionals are reasonable, and entry into the proposed Second Addendum is advantageous to the Bridge Commission;

NOW, THEREFORE, BE IT RESOLVED by the Burlington County Bridge Commission as follows:

- 1. The Commission is hereby authorized to enter into an appropriate Second Addendum to the Services Contract between the New Jersey EZ Pass Group and Xerox State and Local Solutions, Inc. in support of the operation of the New Jersey EZ Pass Customer Service Center.
- 2. The Authority's Executive Director is hereby authorized to execute all written agreements and documents on behalf of the Bridge Commission in this matter, and to do all things appropriate to facilitate the Bridge Commission's entry into the Second Addendum to the Services Contract.

(2) Matters Where the Release of Information Would Impair the Right to Receive Funds: Any matter in which the release of information would impair

	(3) Matters Involving Individual Privacy: Any material, the disclosure of which constitutes an unwarranted invasion of individual privacy such as any records, data, reports, recommendations, or other personal material of any educational, training, social service, medical, health, custodial, child protection, rehabilitation, legal defense, welfare, housing, relocation, insurance and similar program or institution operated by a public body pertaining to any specific individual admitted to or served by such institution or program, including but not limited to, information relative to the individual's personal and family circumstances, and any material pertaining to admission, discharge, treatment, progress or condition of any individual, unless the individual concerned (or, in the case of a minor or incompetent, his guardian) shall request in writing that the same be disclosed publicly.
	(4) Matters Relating to Collective Bargaining Agreements: Any collective bargaining agreement, or the terms and conditions which are proposed for inclusion in any collective bargaining agreement, including the negotiation of the terms and conditions thereof with employees or representatives of employees of the public body.
	(5) Matters Relating to the Purchase, Lease of Acquisition of Real Property or the Investment of Public Funds: Any matter involving the purchase, lease or acquisition of real property with public funds, the setting of banking rates or investment of public funds, where it could adversely affect the public interest if discussion of such matters were disclosed.
	(6) Matters Relating to Public Safety and Property: Any tactics and techniques utilized in protecting the safety and property of the public, provided that their disclosure could impair such protection. Any investigations of violations of possible violations of the law.
	(7) Matters Relating to Litigation, Negotiations and the Attorney-Client Privileges. Any pending or anticipated litigation or contract negotiation in which the public body is, or may become, a party. Any matters falling within the attorney-client privilege, to the extent that confidentiality is required in order for the attorney to exercise his ethical duties as a lawyer.
\boxtimes	(8) Matters Relating to the Employment Relationship: Any matter involving the employment, appointment, termination of employment, terms and conditions of employment, evaluation of the performance of promotion or disciplining of any specific prospective public officer or employee or current public officer or employee employed or appointed by the public body, unless all the individual employees or appointees whose rights could be adversely affected request in writing that such matter or matters be discussed at a public meeting.

(9) Matters Relating to Potential Imposition of a Penalty: Any deliberations of a public body occurring after a public hearing that may result in the imposition of a specific civil penalty upon the responding party or the suspension or loss of a license or permit belonging to the responding party bears responsibility.

NOW, THEREFORE, BE IT RESOLVED by the Burlington County Bridge Commission, County of Burlington, State of New Jersey, assembled in public session, that an Executive Session executive to the public shall be held in the Administration Building of the Commission, 1300 Route 73 North, Palmyra, New Jersey, for the discussion of matters relating to the specific items designated above.

It is anticipated that the deliberations conducted in executive session may be disclosed to the public upon the determination of the Commission that the public interest will no longer be served by such confidentiality.
