#### RESOLUTION NO. 2023-24

RESOLUTION AUTHORIZING 2023 TRAVEL FOR IBTTA AND EZ PASS GROUP EMC MEETINGS AND CONFERENCES

**WHEREAS**, the Burlington County Bridge Commission ("Commission") is a member of both the International Bridge, Tunnel and Turnpike Association ("IBTTA") and the EZ Pass Group, Executive Management Committee ("EMC") organizations; and

WHEREAS, the Commission provides a policy for Commissioners and Commission employees to travel and attend work-related conferences and meetings; and

**WHEREAS**, the Commission has determined that travel for attendance at IBTTA and EMC conferences and meetings is consistent with this policy.

**NOW, THEREFORE, BE IT RESOLVED** by the Burlington County Bridge Commission as follows:

1. The Commission hereby authorizes travel for the Commissioners, the Executive Director and/or other employees or Executive Director designee(s) to attend IBTTA and EMC conferences in 2023.

#### **RESOLUTION NO. 2023-25**

# RESOLUTION APPROVING THE PURCHASE OF UP TO 100 TREES TO PROMOTE SUSTAINABILITY IN BURLINGTON COUNTY COMMUNITIES

- **WHEREAS**, the Burlington County Bridge Commission ("Commission") has identified Sustainability as a desirable goal which can benefit Burlington County residents and Commission toll payers; and
- WHEREAS, the Commission is committed to using its economic development and improvement authority powers for efforts that are consistent with the goals of the Commission; and
- **WHEREAS**, the Commission has identified planting trees as one way to promote Sustainability, and also to generate environmental, economic, and communal benefits for Burlington County residents; and
- **WHEREAS**, the Commission has determined that Thirty-Five Thousand Dollars (\$35,000.00) will provide funding to purchase up to One Hundred (100) trees in Burlington County communities (the "Sustainability Trees").
- **NOW, THEREFORE, BE IT RESOLVED** by the Burlington County Bridge Commission as follows:
- 1. The Commission authorizes the Executive Director to establish and oversee a Sustainability Trees project, which shall include the purchase and subsequent distribution of up to One Hundred (100) trees, at a total cost not to exceed Thirty-Five Thousand Dollars (\$35,000.00), to Burlington County communities.
- 2. The Executive Director shall administer the Sustainability Trees project according to Commission purchasing policies and in compliance with all applicable laws.
- 3. Sufficient funds are available for the purchase of the Sustainability Trees, as evidenced by the Certificate of Availability of Funds, attached.

Vice-Chairwoman Nunes moved to approve. Commissioner Tiver seconded the motion. The motion passed unanimously.

#### **RESOLUTION NO. 2023-26**

RESOLUTION AWARDING A CONTRACT TO REMINGTON AND VERNICK ENGINEERS TO PROVIDE CONSTRUCTION MANAGEMENT AND INSPECTION SUPPORT SERVICES AND UNSPECIFIED TASK OVERSIGHT & CMCI (TASK 32)

WHEREAS, the Burlington County Bridge Commission ("Commission") requires the services of an engineering firm with consulting support expertise to provide construction management and inspection support services for the Commission's Contract No. BCBC-202209 (Task 32, including sub-tasks 32(a) through 32(g)); and

WHEREAS, by way of a fair and open process authorized by N.J.S.A. 19:44A-20.4 et seq., and upon receipt and review of a proposal submitted in response to the Commission's Request for Proposals, ("RFP") for specialized engineering services, pursuant to Resolution No. 2020-78 the Commission determined that the Remington Vernick Engineers firm ("R&V") was qualified to serve the Commission, and

WHEREAS, the Commission also determined that R&V submitted a price proposal for specialized engineering services, which the Commission has identified as Task 32 in Contract No. BCBC-202209, which provided favorable contract terms and conditions for the Commission; and

**NOW, THEREFORE, BE IT RESOLVED** by the Burlington County Bridge Commission as follows:

- 1. The Executive Director and Secretary of the Commission are hereby authorized to execute an Agreement with R&V to provide construction management and inspection support services for the Commission's Contract No. BCBC-202209 (Task 32).
- 2. For engineering construction management and inspection support services work, and for unspecified task oversight and CMCI work that was performed by R&V during the months of January and February, 2023, pursuant to R&V's invoices Nos. BCBCX067-1, in the amount of \$20,877.38, and BCBCX067-2, in the amount of \$37,689.99, respectively, payment to R&V for that work performed, pursuant to the above-referenced invoices, be and is hereby authorized under Task 32 of Contract No. BCBC-202209.
- 3. This contract is awarded through a fair and open process, pursuant to <u>N.J.S.A.</u> 19:44A-20.4 <u>et seq.</u>
- 4. The amount of the contract shall not exceed Three Hundred Thousand Dollars (\$300,000.00), and the contract shall extend for the time period January 3, 2023 to and until completion of work on the project.

Vice-Chairwoman Nunes moved to approve. Commissioner Tiver seconded the motion. The motion passed unanimously.

#### RESOLUTION NO. 2023-27

RESOLUTION AMENDING CONTRACT WITH PENNONI ASSOCIATES FOR CONSULTING SERVICES FOR CONSTRUCTION MANAGEMENT AND INSPECTION OF THE COMMISSION'S STRUCTURAL HEALTH MONITORING SYSTEM PROJECT

**WHEREAS**, requires the services of an engineering firm with expertise in construction management and inspection services related to the Structural Health Monitoring System project ("SHMS"); and

WHEREAS, pursuant to Resolution No. 2020-72, the Commission determined that the Pennoni Associates firm ("Pennoni") was qualified to perform specialized engineering services for the Commission, at contract prices that were deemed advantageous to the Commission, and the Commission awarded a contract for those services to Pennoni; and

WHEREAS, pursuant to Resolution No. 2022-59 the Commission entered into a contract with Pennoni to provide these professional engineering services; and

WHEREAS, Pennoni has performed construction management and inspection services related to the SHMA project pursuant to that contract; and

WHEREAS, the Commission has determined that it is necessary to increase the appropriation for Pennoni's services for that contract by an additional sum of Two Hundred Fourteen Thousand Six Hundred Sixty Dollars (\$214,660.00), due to changes in the baseline construction schedule for startup, installation, and testing.

**NOW, THEREFORE, BE IT RESOLVED** by the Burlington County Bridge Commission as follows:

- 1. The Executive Director and Secretary of the Commission are hereby authorized to execute an amendment to the Commission's Agreement with Pennoni for engineering consulting services for the Commission's SHMS project, consistent with the terms of this Resolution.
- 2. The terms, conditions and duties outlined in Resolution No. 2022-59 appointing Pennoni are incorporated herein by reference, and for the reasons hereinabove expressed, an additional sum of Two Hundred and Fourteen Thousand Six Hundred and Sixty Dollars (\$214,660.00) be and hereby is appropriated to pay the fees, expenses and costs pursuant to the existing contract between the Commission and Pennoni.

- 3. This contract is awarded through a fair and open process, pursuant to <u>N.J.S.A.</u> 19:44A-20.4 et seq.
- 4. The amount of the contract shall not exceed Two Hundred and Fourteen Thousand Six Hundred and Sixty Dollars (\$214,660.00), and the contract shall extend for the time period from April 18, 2023 to and until the completion of work on the project.

Vice-Chairwoman Nunes moved to approve. Commissioner Tiver seconded the motion. The motion passed unanimously.

#### **RESOLUTION NO. 2023-28**

RESOLUTION AWARDING A CONTRACT FOR UNDERWATER INSPECTION AND EVALUATION OF THE BURLINGTON COUNTY BRIDGE COMMISSION BRIDGES TO W.J. CASTLE PE & ASSOCIATES

WHEREAS, the Burlington County Bridge Commission ("Commission") requires the services of an engineering firm with expertise in underwater inspection and the evaluation of bridges; and

WHEREAS, by way of a fair and open process authorized by N.J.S.A. 19:44A-20.4 et seq., and upon receipt and review of a proposal submitted in response to the Commission's RFP for specialized engineering services, pursuant to Resolution No. 2020-78 the Commission determined that W.J. Castle PE & Associates ("W.J. Castle") was qualified to serve the Commission, and

**WHEREAS**, the Commission also determined that W.J. Castle submitted a proposal that provided favorable contract terms and conditions for the Commission.

**NOW, THEREFORE, BE IT RESOLVED** by the Burlington County Bridge Commission as follows:

- 1. The Executive Director and Secretary of the Commission are hereby authorized to execute an Agreement with W.J. Castle for the performance of underwater inspection and the evaluation of bridges for the Commission.
- 2. This contract is awarded through a fair and open process, pursuant to <u>N.J.S.A.</u> 19:44A-20.4 et seq.
- 3. The amount of the contract shall not exceed One Hundred Seventy Thousand Three Hundred Dollars (\$170,300.00), and the contract shall extend for the time period from April 18, 2023 to and until the project is completed.

Vice-Chairwoman Nunes moved to approve. Commissioner Tiver seconded the

motion. The motion passed unanimously.

### **RESOLUTION NO. 2023-29**

RESOLUTION AWARDING A CONTRACT TO CME ASSOCIATES, INC. FOR TRAFFIC ENGINEERING SERVICES AND THE PREPARATION OF STANDARD TRAFFIC CONTROL DRAWINGS FOR ALL COMMISSION BRIDGES

WHEREAS, the Burlington County Bridge Commission ("Commission") determined that it requires the services of an engineering firm capable of providing traffic engineering services and the preparation of standard traffic control drawings for all Commission bridges; and

WHEREAS, by way of a fair and open process authorized by N.J.S.A. 19:44A-20.4 et seq., and upon receipt and review of a proposal submitted in response to the Commission's RFP for specialized engineering services, pursuant to Resolution No. 2020-78 the Commission determined that the CME Associates, Inc. ("CME") was qualified to serve the Commission; and

WHEREAS, the Commission also determined that CME submitted a price proposal for specialized engineering services that provided favorable contract terms and conditions for the Commission.

**NOW, THEREFORE, BE IT RESOLVED** by the Burlington County Bridge Commission as follows:

- 1. The Executive Director and Secretary of the Commission are hereby authorized to execute an Agreement with CME for specialized engineering services for traffic engineering and the preparation of standard traffic control drawings for all Commission bridges.
- 2. This contract is awarded through a fair and open process, pursuant to N.J.S.A. 19:44A-20.4 et seq.
- 3. The amount of the contract shall not exceed Sixty-Two Thousand Five Hundred and Thirty-Three Dollars (\$62,533.00), and the contract shall extend for the time period from April 18, 2023 to and until the completion of work on the project.

Vice-Chairwoman Nunes moved to approve. Commissioner Tiver seconded the motion. The motion passed unanimously.
